
They left 327 sandwiches, which I ate twice a day for a week, running out of Maalox by Thursday. I thought they were whole sandwiches and not just

WHAT IS ETHICAL ADVERTISING?

Let's face it, advertising works. This is America and we are driven to con-sume by ads. Who can forget, "Plop, plop, fizz, fizz, oh what a relief it is", ad campaign of Alka Seltzer? Or today's Nike commercials with Bo Jackson? By the way, Bo does not know medicine.

The point is, in medicine, advertising is becoming more and more common. What is in the future for physician advertising? Will we see such ads as "End of month clearance sale on Cardiac Catheterization" or "For that special Mother's Day gift give her a mammogram"? Will the future be examples of hucksterism such as this or will we, as physicians maintain standards of as physicians maintain standards of

as physicians maintain standards of ethical advertising?

Physicians on the whole are naive when it comes to dealing with an ad agency. We have seen examples in our county where an aggressive ad agency has convinced a physician to run ads, later to find out that they are considered unethical. As a matter of fact, most physicians don't really know the guidelines for ethical advertising. These are well established. The Board of Medicine of the State of Florida has of Medicine of the State of Florida has an advertising statute which clearly states what is considered ethical and unethical for physician advertising. This is administered through the Department of Professional Regulation who maintains licenses in Florida. People who unethically advertise can lose their license in Florida.

PRESIDENT'S MESSAGE (contined from page 1)
is considered ethical. I will not reprint the whole statute for you but rather the highlights for you:
 In Section C, of the Statute, The Board of Medicine states that any advertisement is false or deceptive if it creates unjustified expectations of beneficial assistance. This clearly covers what should be the guidelines of before and after pictures. They must not create false expectations.
 In Section G, the Statute states that you cannot, in an advertisement, list that you are a specialist of a certain Board unless that Board is recognized by the American Medical Association. This has been a problem in our county, as certain Boards which are used in advertisement have not been recognized by the American Medical Association. This maintains the standards of recognition to protect the public from being confused by the terminology of certain Boards. We all know that certain Boards have higher standards of admittance than others. The American Medical Association only recognizes certain Boards which come up to their standards.

In Section I, the Board of Medicine states that you cannot convey the impression that you possess qualifications or skills superior to other physicians.

tions or skills superior to other physicians. We do not know what the future in physician advertising will hold, but we do know what the guidelines are today. This is not an easy editorial to write without making some people upset. I have stuck basically with the guidelines the Board of Medicine has implemented into law in our state. I am writing this so that people may be better informed who have seen advertising change over the last ten (10) years; in addition, I am writing this for the new fifty (50) physicians who are in the process of joining our county within this year. There is certainly a tendency for a new physician who is not busy to consider advertising in some form. I am not discouraging advertising, but simply want to make it clear the form it should take.

take.
It is the responsibility of the Board of Medicine, through the Department of Professional Regulation to protect the public from unethical advertising. We, as a County Medical Society follow these guidelines. If a complaint is made regarding advertising, we use this to determine if a member should remain in good standing in our organization.

The reports were reviewed of the Council on Scientific Activities, chaired by Pierre J. Bouis, Jr., M.D. of Tampa. The Council has the responsilampa. The Council has the responsi-bility to provide continuing medical education through accreditation of hospitals, county medical societies and specialty societies. The Commit-tee oversees the activities of the Com-mittee on Medical Education, Subcommittee on Accreditation, Subcommit-tee on Programs, and workshops for Sponsors of Continuing Medical Education.

Education.

The Council on Specialty Medicine, chaired by Alvin E. Smith, M.D. reported on the Statewide PRO overview by Dr. Charles B. Slonim, Director. Legislative Issues of the FMA. Considered the Voluntary Peer Review Committees established by the Florida Society of Dermatologic Surgeons and Florida Society of Dermatology: Practical Society Society of Dermatologic surgeons and Florida Society of Dermatology; Practice Parameters; Public Health Nursing and Committee on Allied Health Professions. The Council reviewed the applications of twenty-three special societies due for re-recognition by the

Tanning Facilities Regulation: The Council concurred with the Florida Society of Dermatology that tanning facilities in Florida need to be regulated for the protection of the public's health and recommended that the FMA seek legislation.

DRIVER'S TRAINING FOR THE PHYSICALLY IMPAIRED

Lee Memorial Hospital is pleased to offer an Adaptive Driver's Evaluation and Training Program for the physically impaired through its Rehabilitation Center. Driving is now an attainable goal for many spinal cord, brain injured, stroke, amputee and other rehabilitation patients.

First, there is an assessment of the potential participant by an occupational therapist from the hospital's Rehabilitation Center. Physical, cognitive, visual and perceptual abilities are measured through a computerized program to provide information on the client's functioning related to the safe operation of a motor vehicle.

The second phase inloudes a behind-the-wheel assessment and training on the Fort Myers High School Driver's Training Course by an occupational therapist who is also a Certified Driver's Training Instructor.

The final phase is an evaluation of the client's abilities to safely operate a motor vehicle on public roadways.

The custom designed, specially adapted car was purchased through funds raised by Lee Memorial Hospital's Development Program, including donations from the Family of Friends Annual Giving Program, Neurology Associates of Lee County and Home Medical Equipment Company. Dear Provider/Supplier:

The purpose of this letter is to inform you that the 14 day payment hold policy will be reinstituted for claims received on and after October 1, 1990. When the payment hold policy was first implemented on July 1, 1988, some providers and suppliers experienced cash flow problems. We believe that your members can minimize the reoccurrence of such problems on October 1, 1990, by doing two things:

- 1. Managing their funds in a way that recognizes and accommodates the reduction in cash flow that will occur in the first half of October 1990, and
- 2. Filing claims early enough for them to be received by us before our last work day in September - Friday, September 28, 1990. While we encourage the early filing of claims, we would appreciate your members not waiting to the last day to file such claims. This could create an unmanageable volume of claims in a very short period of time.
